3. New vendors or vendors with new work: mail or email 3-5 photos of *all* categories of work to be displayed or sold. Work not represented in your application will NOT be allowed.
4. Copy of your Wisconsin Department of Revenue Seller Permit.
5. You will be notified of acceptance via email or letter.
6. Provide self-addresses stamped envelope with sufficient postage for return of your materials.

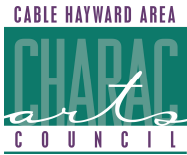

NAMF Terms and Conditions for Vendors

- **Submission deadline for payment and all application materials is May 31, 2017.**
- **Artwork must be handmade by the artist and of original design. No commercial, flea market, country crafts, buy/sell items, kits or molds allowed.**
- **For new vendors, we require photographs showing each category of product you intend to display and/or sell. You will be required to remove any items in your booth that were not submitted to and approved by the Vendor Review Committee. This is a Fine Art and Fine Craft Show.**
- **\$30 fee on all returned checks.**
- **Absolutely no guarantees/reservations for booth location will be made to any vendor. To create the most effective event layout, vendor booth assignments will be made entirely at the discretion of the show coordinators, although preference will be given to those applications that are received first.**
- **Outdoor show, rain or shine. Booth shelters/tents are to be supplied by the exhibitor.**
- **Electric hook-up is not available and generators are not allowed.**
- **Event coordinators will be on site from 6 – 8 PM on Friday evening and from 7 AM on Saturday morning.**
- **NO overnight camping.**
- **Except for unloading/loading, vendor vehicles are to be removed from the Sawmill Saloon/Mooselips Java Joint parking lot and parked at the nearby Lenroot Lodge. Violators will be towed.**
- **Vendors are responsible for maintaining a clean booth space.**
- **Display materials are to be supplied by the exhibitor. The Sawmill Saloon/Mooselips Java Joint and CHARAC are not responsible for loss or damage to artwork or display material.**
- **Booths are NOT to be torn down prior to 5 PM. Those doing so will not be invited back.**
- **No refunds for cancellations to the Event Coordinator after noon on June 25, 2017.**
- **Vendors who are “no shows” without explanation may not be invited to, or accepted for participation in future shows.**
